Governor Martinez Announces the Grand Opening of the MVD's New West Side Location

Albuquerque, N.M. – Today, Governor Susana Martinez announced the grand opening of the Eagle Vista MVD Office. The Eagle Vista MVD Office is the newest Motor Vehicle Division Office, located on the West Side of Albuquerque. The Eagle Vista office will service northwest Albuquerque, Corrales, Rio Rancho, Sandoval County and Northern Bernalillo County.

“Since day one, we’ve made it our mission to improve MVD customer service for New Mexicans and re-opening an office in Northwest Albuquerque will help the MVD better serve the people of New Mexico,” said Governor Susana Martinez. “This office helps us reach our goals of making state government more efficient and improving customer service.”

The Eagle Vista Office fills the need for an MVD Office in Northwest Albuquerque and better balances the workload for offices in the metro area. The Eagle Vista Office is the first MVD Office to operate in Northwest Albuquerque since the Cottonwood Mall Office was closed in 2010.

“For seven years, thousands of people have driven across town to get MVD services and now we’re bringing the services closer to those customers,” said John Monforte, Acting Secretary of the New Mexico Taxation and Revenue Department. “This office better serves the people of New Mexico and allows us to provide a broader range of services to the community.”

In November, the MVD closed the Metro Court MVD in downtown Albuquerque to move services to the Eagle Vista MVD Office. The Metro Court MVD served an average of 6,500 customers while Eagle Vista is estimated to serve over 10,000 a month. Additionally, due to the poor parking and traffic situation in downtown Albuquerque, the Metro Court Office could not provide driving tests or VIN inspections. The Eagle Vista

MVD will be a full service MVD Office, providing a full range of driver and vehicle services.

The Eagle Vista MVD Office is located at 9651 Eagle Ranch Road Albuquerque, NM 87114.

In recent years, MVD has made enormous improvements in customer service. MVD has implemented a new computer system, which replaces the MVD's 25-year-old computer system, and launched the Mobile Unit to serve rural communities across New Mexico.

The New Mexico Motor Vehicle Division, a division of the Taxation and Revenue Department, is responsible for administering driver's licenses and vehicle registrations in New Mexico. MVD operates 33 field offices and partners with municipalities and private vendors across the state to administer services to New Mexicans.
